The following item(s) are scheduled to be heard on December 5, 2023:

Resolution & Order 2023-416: The Lyons-Mehema Water District is requesting an easement across the property at John Neal Park. The Lyons-Mehama Water District is replacing an undersized and aging steel potable water reservoir on McCully Mountain. A permanent pipeline improvement connecting the dead-end waterline at the east end of Juniper Street to another dead-end waterline at the intersection of 13<sup>th</sup> Street and Dogwood Street in the City of Lyons is required to enable the existing reservoir to be taken offline and replaced. During construction, the looped connection will allow water from the District's north reservoir to flow to the southern and eastern portions of the District's service area and after construction the pipeline will provide improved fire flows as well as provide additional operational flexibility. During design of the project, the District coordinated with Linn County Parks and adjusted the proposed pipeline alignment based on Parks input as well as successfully applied for an in-waterwork waiver to allow construction to happen outside of the normal park camping window.

Financial Impact: None. Costs paid by Lyons-Mehema Water District.

RE: PROPOSAL FOR ROAD NAME CHANGE: STELLMACHER DR, CR 0104

The Linn County Road Department received an application requesting to change the name of Stellmacher Dr., County Road No. 104. Staff members have reviewed the provisions of Linn County Code 960.100 through 960.600 and have taken steps to comply with the requirements of LCC 960.400, *Processing Road Name Applications*.

Pursuant to LCC 960.400(E), Road Department staff notified affected departments and agencies, including emergency services. Emergency services rejected one proposed alternative name due to similarity with another road in the emergency response area. GIS department staff observed that the name change would necessitate addressing changes.

Addressing changes will create an administrative burden to agency personnel due to re-labelling maps, re-addressing affected properties, emergency services location and identification information, and similar administrative obligations incurred by the proposed name change. The owners and residents of affected properties would be responsible for managing these responsibilities for themselves with regard to re-addressing their driver licenses, banking and tax information, notifying the post office, and all other entities with an interest in corresponding with or recording their address.

Pursuant to LCC 960.400(F), Road Department staff mailed a letter to property owners holding properties served by Stellmacher Drive. Road Department staff determined that there are eight residential addresses on seven tax lots served by Stellmacher Drive. The letter notified these property owners and/or residents of receipt of the application for the name change and solicited their comments. LCC 960.400(F) states that the purpose of this provision of code is to "determine general consensus regarding the proposed name."

Road Department staff received four letters in response, copies of which are attached hereto. All letters received are opposed to the proposal to change the name of the road. Not all letters were submitted by the deadline included in the initial letter, but were received prior to the writing of this memorandum. Of the four letters received, one (Gary Chandler and Maggie Down) appears to have a current ownership interest in a property served by Stellmacher Dr.

The Linn County Road Department recommends against changing the name of Stellmacher Dr. The proposal imposes an administrative burden on Linn County departments and other agencies that is not supported by any perceived benefit to the general public. It would create a precedent that, if followed, could lead to confusion, burdensome costs to the County and citizens, and potentially to public safety. Historical continuity with regard to the naming of public landmarks, including roads, provides a benefit to the public.

In addition to the above, the applicant does not appear to have gained consensus among all properties served by Stellmacher Dr. One property appears to offer opposition. Two properties did not respond to the applicant nor to Road Department correspondence.

We do not perceive that this proposal serves to "promote the health, safety, and welfare of the public."

- 1. Name limited to a maximum of twelve letters (12) and two (2) words.
- 2. No duplication with other existing road names.
- 3. No similar sounding or confusing names.
- 4. The designation of roads shall generally conform to the following:
  - a. Roads running generally North-South shall be known as roads or streets.
  - b. Roads running generally East-West shall be known as drives or avenues.
  - c. Roads dead-ending 1000 feet or less from their beginning points shall be known as ways or courts.
  - d. Roads whose beginning and ending points intersect on a common road shall be known as loops.
  - e. The name of a private road shall be known as a lane.

**Reason For Request:** The Stellmacher family has sold all of their property on this road and are no longer residents. At one time they were the primary property owners/farmers on this road and likely why the name was changed from SW 30<sup>th</sup> originally when my grandfather lived here. Also, the current road name is long and has to be spelled out each and every time it has to be given out which can be frustrating. A shorter more common name without a family name will eliminate this situation in the future as properties change hands. The road was originally SW 30<sup>th</sup> Ave and that would be the preferred name again if possible.

The Linn County Road Department has received an application to rename Stellmacher Drive SW. This application included signatures of approval from the majority of residents or property owners on Stellmacher Drive. Proposed alternative names for the road include the following:

- Starlight Drive SW
- Moonlight Drive SW
- Midnight Drive SW
- Twilight Drive SW

The Linn County Road Department has submitted this application for review to agencies and departments affected by the proposed name change. Resulting from that review, Starlight Drive SW has been eliminated as a potential name due to redundancy with another road by that name within this emergency response area.

Please note that if the proposal is approved, residence addresses will have to be changed. House numbers are assigned by the Linn County Geographic Information Systems Department. Residents will need to update address information on IDs, banks, postal service, and etc.
