Bid Opening – Cedar Creek (Mill City) Pedestrian Bridge Project

Resolution & Order 2024-060 – Delegation of Authority, Purchase of Supplies Contract

This is a Resolution & Order to approve a delegation of authority to Wayne Mink, Roadmaster for purchase of liquid asphalt emulsion for the 2024 chip seals project. This purchase contract is between Linn County and Western Emulsions Inc.

Resolution & Order 2024-070 – Acceptance of a Road Dedication – Old Salem Road, CR 367

R&O 2024-069 Sub-recipient Agreement for 5311 COVID Relief funds from ODOT Agreement 35641:

During the COVID pandemic, special relief funds to support Public Transportation Service Providers have been disbursed from Federal resources by ODOT. This was established to assist providers in maintaining services through a long period of reduced ridership and to increase staff/driver retention allowing for hazard pay in the public facing positions.

ODOT announced the end of COVID Relief Funding with a final opportunity to apply and exhaust the remainder of the resource. Linn County assisted in applying for operating assistance on behalf of Senior Citizens of Sweet Home, Inc. The Linn County/ Senior Citizens of Sweet Home, Inc. application was selected to receive a portion of the remaining funds and because the application scored high, were awarded above the value in the application request.

ODOT Agreement 35641 was reviewed and approved by the Board of Commissioners at a public meeting held on February 6th, 2024.

R&O 2024-069 establishes a Sub-recipient Agreement with Senior Citizens of Sweet Home, Inc. to receive Federal 5311 funds with Linn County fulfilling the role as QE, bridging the gap between funding opportunities and the transportation provider in need.

R&O 2024-066

This Agreement outlines the terms between Linn County and the King County Directors Association Purchasing Cooperative (KCDA) agreement number 25-255. Linn County will procure two 12 by 60-foot modular units, including an ADA ramp, for the Willamette Health Center location. The total cost for the modular units shall not exceed \$317,222.00. These modular units will serve as additional conference rooms to support our Developmental Disabilities program.

R&O 2024-067

This is a Person Services Contract between Linn County and Samaritan Health Services for Psychiatric Services. Linn County will pay \$6,453.00 per month for eight hours per week of a psychiatrist to provide care in the community to Linn County individuals with a diagnosis of serious and persistent mental illness.
