



# LINN COUNTY ROAD DEPARTMENT JOB ANNOUNCEMENT

**CLASSIFICATION TITLE: SEASONAL ROAD MAINTENANCE WORKER 1**

**CLASSIFICATION NUMBER: 240**

**CLASSIFICATION CATEGORY: TEMPORARY, FULL-TIME**

The Linn County Road Department is accepting applications for 15 seasonal road maintenance workers. These are temporary, full-time positions lasting approximately three months, typically from early June through mid-September.

The Linn County Road Department provides on-the-job training.

**ESSENTIAL FUNCTIONS OF THE JOB:** Duties include but are not limited to:

- Work Zone Traffic Control, "Flagging" – Safely direct and control traffic in and around work zones.
- Manual Labor – Perform manual labor including but not limited to cutting and removing roadside vegetation; removing obstacles from roadways; clearing trash and debris from the right-of-way; loading and unloading materials; installing and/or repairing fences, rails, and signposts.
- Road Surface Maintenance – Work with very high temperature equipment and materials to manually seal roadway surfaces; patch and repair roadways; and sand slippery, flushed, or "bleeding" road surfaces.
- Equipment Operations – Operate light duty pickup trucks, compaction equipment (rollers), self-propelled brooms, and/or other equipment as needed. Operate power tools and hand tools.
- Exposure - Work is performed outdoors in all types of weather and in all areas of the County.
- Performance - Must be able to work continuously in a productive manner, with a professional demeanor; understand and execute directions; and effectively communicate and work with others.

**QUALIFICATIONS:**

- Graduation from a high school or possession of a GED Certificate
- Possession of a valid Driver License and an acceptable driving record
- Work requirements include being able to see, talk, hear, bend, stoop, kneel, jump and run; the ability to sit, stand, and walk all day; the ability to use hands to finger, handle, or operate objects, tools, and controls; the ability to reach with hands and arms, and will lift or move ninety (90) pounds.
- Must be capable of working all day exposed to sun and heat; or rain and cold.
