**Legislative History of Chapter S102** 

#### S102.005 Title [reserved]

#### S102.010 Legislative policies

(A) WHEREAS, the Board has authority under ORS 203.035 to adopt ordinances which allow the expenditure of public funds for public purposes; and

(B) WHEREAS, there are several non-profit corporation and quasi-governmental non-profit organizations which provide services for the public good such as assistance to senior citizens of the county, assistance to the youth of the county, assistance to the handicapped citizens of the county, and a source of input for providing medical services for county residents; and

(C) WHEREAS, the Attorney General of the State of Oregon has issued a formal opinion, number 7783, which

indicates that this type of expenditure is proper when the public funds are expended for a public purpose; and

(D) WHEREAS, the Linn County Board of Commissioners has determined that the following agencies are providing services which serve a public purpose and therefore are entitled to the funds in the following amounts as authorized by the Linn County Budget Committee:

(1) Willamette Valley Rehabilitation Center \$24,000.00

(2) Linn Association for Retarded Citizens \$4,224.00

(3) Western Oregon Health Systems Agency -District 4 Subarea Advisory Council \$6,692.00

(4) Aging Services Inc. \$1,650.00

(5) Linn-Benton Homemaker Service \$10,000.00. [The text of LCC \$103.010 appeared in the legislative history section of Ordinance 80-233 eff 7/2/80. It was not adopted as ordinance but is set forth in full here for its legislative history.]

# S102.100 Expenditures of public funds authorized for certain entities

The expenditures approved by the 1980-81 fiscal year Linn County Budget Committee for public purposes shall be expended as follows:

(A) Willamette Valley Rehabilitation Center \$24,000.00

(B) Linn Association for Retarded Citizens \$4,224.00

(C) Western Oregon Health Systems Agency - District 4 Subarea Advisory Council \$6,692.00

(D) Aging Services Inc. \$1,650.00

(E) Linn-Benton Homemaker Service \$10,000.00.

#### S102.150 Requirement of a contract

Prior to the expenditure of the funds authorized in LCC S103.100, each of the five (5) entities set forth therein shall enter into a contract with Linn County which shall be prepared by the Board of Commissioners which will insure that the funds will be spent for a public purpose, that if the funds are not spent for a public purpose they will be returned to Linn County, and that if a court of competent jurisdiction rules that this chapter is legally deficient that the foregoing entities will repay the sums to Linn County. ## S102.800 Emergency provision

(A) The provisions of ORS 203.045 were compiled with [sic] during the regular Board of Commissioners meetings of July 2, 1980 and the Board of Commissioners further finds that an emergency exists and the best interest of the citizens of Linn County will be served by this chapter being effective upon passage.
