S104.005 Title [reserved]

S104.010 Legislative policies

(A) Counties, acting by their governing bodies have authority under ORS 203.035 to adopt ordinances which allow the expenditure of public funds for public purposes; and

(B) The non-profit corporation known as Willamette Valley Rehabilitation Center, provides a service for the public good by assisting handicapped citizens of the county; and

(C) The Attorney General of the State of Oregon has issued a formal opinion, number 7783, approving this type of expenditure when the public funds are expended for a public purpose; and

(D) The Linn County Board of Commissioners agrees that the Willamette Valley Rehabilitation Center provides services which serve a public purpose and therefore are entitled to the amount of \$1000 during fiscal year 1983-84, as authorized by the Linn County Budget Committee. [The text of LCC \$104.010 appeared in the legislative history sections of Ordinance 83-377 eff 8/31/83. It was not adopted as ordinance but is set forth in full here for its legislative history.]

S104.100 Expenditures of public funds authorized for certain entities

The expenditure approved by the 1983-84 fiscal year Linn County Budget Committee for services provided to citizens of Linn County by the Willamette Valley Rehabilitation Center of \$1,000.000 be allowed. [Adopted 83-377 §1 eff 8/31/83]

S104.150 Requirement of a contract

Prior to the disbursement of the funds authorized in LCC S104.100, Willamette Valley Rehabilitation Center shall enter into a contract with Linn County, to be prepared by the Board of Commissioners, which will insure that the funds will be spent for a public purpose, that if the funds are not spent for a public purpose they will be returned to Linn County, and that if a court of competent jurisdiction rules that this chapter is legally deficient that the funds will be repaid to Linn County.

S104.800 Emergency provision

(A) The provisions of ORS 203.035 to 203.045 were compiled with [sic] during the regular Board Meeting of August 31, 1983, and the Board of Commissioners finds that this Chapter is necessary for the immediate preservation of public peace, health and safety, and this Chapter takes effect upon its passage. [Adopted 83-377 §3 eff 8/31/83]
