## **ESSENTIAL FUNCTIONS OF THE JOB:**

- Research the availability and quality of parts and supplies.
- Contact vendors for price quotes
- Maintain computerized inventory of parts and supplies; fleet records for Road Department; inventory records of parts and supplies issued to department maintenance districts
- Stock and maintain a complete inventory of stockroom for most needed equipment, parts and supplies
- Inspect all invoices of purchases for Road Department
- Maintain and update equipment maintenance file which involves filing all work orders, listing charge-outs and credits for parts and labor by equipment number, update computerized vehicle maintenance history file.
- Works under and supports the Purchasing Agent 2
- Will lift and carry up to fifty (50) pounds
- Develop and maintain effective, harmonious and reasonable work relationships with others.
- Maintain regular and predictable work attendance.

## **QUALIFICATIONS:**

- Possess thorough knowledge of automotive and equipment parts, sources of supply and parts catalogs.
- Thorough knowledge of inventory recordkeeping and control methods.
- Considerable knowledge of purchase and requisition procedures.
- Graduation from high school and two (2) years of experience involving responsibility for purchasing equipment, supplies and inventory; or any satisfactory equivalent combination of experience, education and training.
- Possession of a valid driver's license and an acceptable driving record.
